A gift in your Will enables you to make a planned gift to a charity that you care about.

Charitable legacies are paid before tax is deducted, therefore reducing the amount of tax that must be paid when your estate is being distributed.

A gift in your Will can take the form of:

- A Residuary Gift this is the remainder or part of the remainder of your estate once all debts. tax, expenses and other legacies are paid
- A Pecuniary Gift this is a specific sum of money pledged to charity
- A Specific Gift this can be property, stocks and shares or other valuables such as a piece of jewellery.

Leaving a gift to charity can have significant tax advantages depending on the amount you leave. We recommend you take proper advice on the tax consequences from a suitably qualified solicitor or tax adviser to understand the tax benefits before leaving the gift.
